Statement for Annual Plan Beginning 10/1/22

The Boonton Housing Authority (BHA) has converted it's conventional public housing units to HCV project-based vouchers through HUD's Streamline Voluntary Conversion Program. BHA has contracted with AHOM Inc. (a non-profit) to manage the housing developments at Riverview and Chestnut Street Cottages.

See below descriptions of both developments:

RIVERVIEW APARTMENTS

The Riverview Apartments locates at 122 Plane Street Boonton NJ is a high-rise apartment building that consists of multi-family housing of studios to 4-bedroom apartments. The management of the apartment complex continually updates the apartments and the common areas to ensure the quality of life our tenants deserve. This site has an on-site laundry facility as well as parking for our tenants and a beautiful playground and basketball court for our younger tenants to enjoy with their families.

Also available is a community room for our tenants to use for parties and family gatherings as well as meetings and holiday get togethers. The tenants as well as management try to keep our facility a family atmosphere where everyone knows everyone and treat one another with respect and dignity. Through the years we have made great progress in not only bringing the tenants together but bringing the community together as well.

CHESTNUT STREET COTTAGES

Chestnut Street cottages consist of 14 one-bedroom apartments. Our grounds speak for themselves with a beautiful gazebo for evening get togethers surrounded by a beautiful landscape. Each apartment has a private patio for our tenants so they can enjoy sitting outdoors and enjoy life as they should. An on-site laundry facility makes it convenient for our tenants to do their laundry while not being far from home. Our quiet atmosphere blends perfectly in with our neighbors and this is what makes the Chestnut Street Cottages a little bit of heaven on earth.

The BHA manages a Housing Choice Voucher program (HCV) with approximately 231 vouchers throughout the town of Boonton, New Jersey.

BHA plans to continue to work with AHOM Inc. toward making improvements at both of its developments (Riverview and Chestnut Street Cottages) including (but not limited to): upgrades and updated to heating systems, upgrades to kitchens, plumbing and electrical, hallways and entryways, roofing, sidewalks and grounds. BHA also plans to continue to operate it's HCV program and expand affordable housing opportunities throughout the town of Boonton, New Jersey.
